SAFETY/WHAT TO EXPECT

Tours will provide necessary personal protective equipment. To fully participate in tours, guests should be able to:

- Stand for up to 45 minutes
- Navigate stairs and steel grating without canes, walkers, crutches, walking boots or any other aide that may be a tripping hazard.
- Withstand temperatures in excess of 100° for up to 10 minutes.
- Ride in bumpy, off-road conditions for up to 90 minutes for coal mine tours.
